

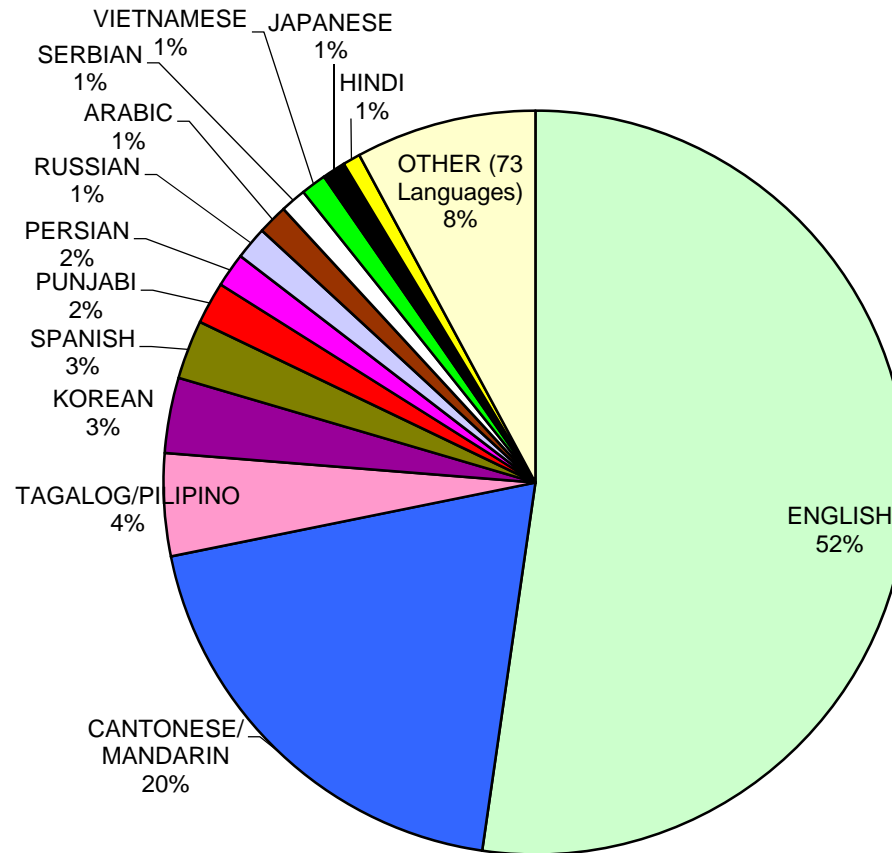

Access to Services for Residents With Uncertain or No Immigration Status

Burnaby Board of Education Practice and Procedures

The District endeavours to do everything it can to allow all students to receive a publicly funded education while recognizing constraints established within Ministry of Education funding policies and other regulatory frameworks.



As is always the case, for parents who do not have the proper immigration documents, determination of eligibility for a publically funded education will be reviewed on a case-by-case basis, with care and sensitivity.



The district recognizes that confidentiality of personal information is important and that parents / legal guardians need not be afraid to come to the Burnaby School District.



While the school district recognizes the federal government's legal jurisdiction on immigration matters, it is not the role of the school district to share immigration status information with external federal agencies unless legally ordered to do so.



Children of Refugee Claimants can be provided with a publically funded education while their claim is being processed. Refugee Claimants who have been denied permission to stay in Canada and people on expired work / study permits would need to be considered on a case-by-case basis by district staff to confirm eligibility.



District staff and Settlement Workers in Schools may inform parents / legal guardians about other community, religious or independent training opportunities for children who do not qualify for a publically funded education – until the parent / legal guardian can provide proof of eligibility for funding purposes.
